1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2022-23 was £8.82 per elector.

In 2022-23, the Council made payments totalling £1550.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.




Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2023 of **Mold Town Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Accounting Statement

I am unable to conclude whether or not the Accounting Statement properly presents the Council's receipts and payments and financial position:

- The Council has not kept adequate records to support the total other receipts figure.

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 3: Compliance with relevant laws and regulations. The Council has not published information it is required to publish electronically by the Democracy and Boundary Commission Cymru etc. Act 2013.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Budget and precept


While the Council did prepare a budget for the year and calculated its budget requirement, it is not clear if the Council considered its reserves in accordance with the Local Government Finance Act 1992. Furthermore, when setting the precept, it only recorded an increase to the previous year's precept. It did not specify an amount.

We recommend that the Council's minutes clearly document its consideration of its retained reserves and records the actual precept it resolves to levy.

Trust Fund Annual Governance Statement Disclosure

The Council has marked "No" to the disclosure box 9 within the annual governance statement which is inconsistent with the prior year disclosure and the assertion made by the Internal Audit report. We recommend that the Council prepares the Annual Governance Statement in line with the practitioners' guidance.

There are no further matters I wish to draw to the Council's attention.
